Supply of Utility Panel Vehicles

The Lebanese Government has received financing from the Kuwait Fund for Arab Economic Development toward the cost of the Lebanese Municipal Services Emergency Project, and intends to apply part of the proceeds toward payments under the contract for Supply of Equipment for Municipalities.

The Council for Development and Reconstruction, the project implementing agency, now invites sealed bids from eligible bidders for the supply of 10 Utility Panel Vehicles. The supply period is 2 months.

Bidding will be conducted through the national Competitive Bidding procedures, and is open to all eligible bidders.

Bidders will be subject to post qualification and shall meet the following qualification criteria:

- Minimum average annual turnover of one million US\$ (1,000,000\$), within the last three (3) years.
- The Bidder shall be an established distributor/dealer in Lebanon for a minimum of five (5) years, supplying and providing maintenance of same goods type as submitted in his offer shall be one of his activities as established from the company's sales records, Client certificate, bills... for the last five (5) years.
- The proposed good's (type and brand) should be available in the Lebanese market since at least 5 years.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Council for Development and Reconstruction at the address given below during office hours from 9:00 to 15:00 hours Beirut local time from Monday till Friday.

A complete set of bidding documents may be purchased by interested bidders from the address below, on application in person and upon payment of a nonrefundable fee of five hundred dollars (500\$) starting from **Monday, October 2nd 2017**. The method of payment will be through a bank certified check in favor of the council for development and reconstruction.

Bids must be delivered to the address below no later than **Tuesday, October 24<sup>th</sup>, 2017 at 12:00 noon Beirut local time**, at which time they will be opened in the presence of bidders' representatives who choose to attend. Late bids will be rejected. Electronic bidding will not be permitted.

All bids must be accompanied by a bid security of Four Thousands five hundred United States Dollars(4500) USD
