the Lebanese Municipal Services Emergency Project, and intends to apply part of the proceeds toward payments under the contract for Supply of Equipment for Municipalities.

The Council for Development and Reconstruction, the project implementing agency, now invites sealed bids from eligible bidders for the supply of 44 Skid Steer Loaders. The supply period is 6 months.

Bidding will be conducted through the national Competitive Bidding procedures, and is open to all eligible bidders.

Bidders will be subject to post qualification and shall meet the following qualification criteria:

- The Bidder shall be an established dealer for a minimum of five (5) years, supplying and providing maintenance of same goods type as submitted in his offer in Lebanon shall be one of his activities as established from the company's sales records, Client certificate, bills .. for the last five (5) years.
- The proposed good's (type and brand) should be available in the Lebanese market since at least 5 years.

The Bidder shall furnish, as part of his bid, documentary evidence that it meets the following financial requirement(s):

- Submission of original or certified copies of audited balance sheets or if not required by the law of the bidder's country, other financial statements acceptable to the Employer, for the last four (4) years to demonstrate the current soundness of the bidders financial position and its prospective long term profitability.
- Minimum average annual turnover of (1) one Millions US \$, calculated as total certified payments received for contracts in progress or completed, within the last four (4) years.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Council for Development and Reconstruction at the address given below during office hours from 9:00 to 15:00 hours Beirut local time from Monday till Friday.

A complete set of bidding documents may be purchased by interested bidders from the address below, on application in person and upon payment of a nonrefundable fee of Five Hundred Thousand Lebanese Pounds (500.000 LBP) starting from Tuesday March 23rd, 2021. The method of payment will be through a bank certified check in favor of the Council for Development and Reconstruction.
