The Government of Lebanon has received financing from the World Bank toward the cost of implementation of the Greater Beirut Water Supply Project (GBWSP). The Council for Development and Reconstruction (CDR), Project's implementing agency, intends to apply part of the proceeds toward payments under the contract for the Pipeline and Ancillaries.

The CDR now invites sealed Bids from eligible Bidders for the implementation of the Pipelines and Ancillaries remaining works, including implementation of about 3.5 km of twin 1400mm ND Ductile Iron Pipes and complete outstanding works in the installed section of the pipeline. The implementation period is estimated for 18 months.
