The Government of Lebanon has received a loan from the World Bank toward the cost of the Roads and Employment Project, and intends to apply part of the proceeds toward payments under the Contract for the **Supply of “Personal Protective Equipment (PPE) to MPWT Snow Clearing Operators”**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank’s Disbursement Guidelines for Investment Project Financing.
2. The **Council for Development and Reconstruction (CDR)** now invites quotations from suppliers for the Supply of “Personal Protective Equipment (PPE) to MPWT Snow Clearing Operators”, delivered within a time period of 60 days subsequent to the signature and notification of the contract). More details on the Supply are provided in the RFQ documents.

Bidding will be conducted through national competitive procurement using a Request for Quotations (RFQ) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” dated July 2016 and revised Nov 2017 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from the Council for Development and Reconstruction and inspect the bidding documents at the address given below from 9:00 to 15:00 hours from Monday till Friday.
5. The bidding document in English may be purchased by interested Bidders upon the submission of a written application to the address below and for free. The document is to be picked up by a person duly authorized by the applicant.
6. Quotations must be delivered to the address below at or before 12:00 noon Beirut Local Time on **Monday November 27<sup>th</sup>, 2023**. Electronic Bidding will not be permitted. Late Quotations will be rejected. Bids will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend at the address below at 12:00 noon Beirut Local Time on **Monday November 27<sup>th</sup>, 2023**.
7. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder’s beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form to be included in the bidding document.
