#### **Meeting Overview**

The Consultant commenced the meeting with a detailed presentation of the project and tender documents. Following the presentation, the attending Contractors' representatives raised several questions, which were addressed by both the Employer and the Consultant as follows:

#### **Questions and Answers**

# Q1:

What would be the impact if the porous concrete used for the dam drainage system is affected by freezing? What is the thickness of the porous concrete? Is it sufficient for the dam drainage under the membrane?

#### A1:

Beyond applying the necessary treatments to minimize freezing effects, the primary function of the porous concrete is to fill the voids between the dam's facing rocks, up to a depth of 80 cm, limiting their movement and insuring a firm base to apply the membrane. This function is not significantly impacted by potential freezing. Yes, it is sufficient to ensure a proper drainage system.

#### Q2:

Can the reservoir berms be modified by material filling into a uniform slope before membrane installation?

#### A2:

Flattening the upstream lake slopes would either require additional land, which is unavailable, or result in a reduction in lake volume, which is, in both cases, not considered by CDR.





Q3:

Can the physical protection of the membrane on slopes be achieved using a double-layer membrane?

A3:

No, the physical protection must be provided by materials capable of withstanding external factors as specified in the bidding documents.

Q4:

Can a proposed sub-contractor for membrane installation (≥100,000 m²) be accepted without official documentation?

A4:

Yes, the sub-contractor can be accepted based on certifications and documented experience (both locally and internationally). Additionally, if the main contractor meets these requirements, a sub-contractor may not be necessary.

Q5:

Should the bidder submit an official version of the PLI (Public Liability Insurance) for 10 years, amounting to 1 MUSD, concerning the lining complex?

A5:

No, at the bidding stage, only a draft version of the PLI is required.

O6:

Are two separate bank performance guarantees required for the two sections of the project?

**A6** 

No, a single bank performance guarantee covering the signed contract's value, is sufficient.

Q7:

Can you confirm that the operation and maintenance period for the project is two years?

A7:

Confirmed.

**Discussions & Additional Notes** 

- One of the Contractors requested the AutoCAD version of the project drawings. These files are
  provided for information purposes only and must not be used in the bid submission. (AutoCAD
  files attached.)
- The Consultant drew the attention of the bidders for 2 errors detected in the following bid forms, and kindly requested them, to proceed with the following corrections (attached updated qualification forms 1 and 2 to replace the same tender forms):
  - 1. Qualification Form 1 (Annual Turnover):
    - Replace "Euros" by "US\$", such the paragraph will be read as follows:
      - "... in terms of the amounts billed to clients for each year for work in progress or completed, converted to US\$ at the exchange rate at the end of the reported period ..."
    - Update the table's third column header to be read as follows:

"US\$ Equivalent."

2. Qualification Form 2 (General Experience Record):

Replace "water and wastewater" in the sentence preceding the table, by "civil works", such the paragraph will be read as follows:


"The bidder should list all completed civil works projects within the last ten years."
