1	<p>According to the tender requirements paragraph Section II Qualification Criteria and Requirements Table line 4.2 (8) mentioning that "For the above and any other contracts completed and under implementation as either a prime contractor and/or joint venture member, between 1st January 2010 and application submission deadline, a minimum construction experience in the following key activities successfully completed: i) Design & Construction of a WWTP Conventional Activated Sludge (CAS) process including sludge treatment, anaerobic digestion and energy generation with a minimum value of Forty Million Dollars (40,000,000 Dollars)"</p> <p>Please confirm whether the key activities of the WWTP projects (process including sludge treatment, anaerobic digestion, and energy generation) should be fully covered by each project separately or should be fully covered by all projects cumulatively, as each project could cover at least one of the required activities.</p>	<p>"Design & Construction of a WWTP Conventional Activated Sludge (CAS) process including sludge treatment, anaerobic digestion and energy generation with a minimum value of Forty Million Dollars (40,000,000 Dollars)"</p> <p>must be fulfilled by at least one project. All the specified components (sludge treatment, anaerobic digestion, and energy generation) should be included within a single contract with a minimum value of USD 40 million.</p> <p>Cumulative experience across multiple projects does not satisfy this specific requirement.</p>
